The following is a summary of the requests for funds made by the 89th (2023) General Assembly to the churches **for 2024**, and directions as to where to send those funds.

(1) **GENERAL ASSEMBLY OPERATION FUND:** The Assembly requested the churches to contribute **\$20.00 for each communicant member** to the 2024 General Assembly Operation Fund.

Contributions to the General Assembly Operation Fund should be made payable to *The Orthodox Presbyterian Church*, marked “GA Operation Fund,” and sent to 607 Easton Rd., Bldg. E, Willow Grove, PA 19090-2539, after January 1, 2024.

(2) **TRAVEL FUND:** The General Assembly requested the churches to contribute **\$12.00 per communicant member** to the 2024 General Assembly Travel Fund. This is the fund that pays for the travel of commissioners to the 2024 General Assembly.

Contributions for Travel Fund should be made payable to *The Orthodox Presbyterian Church*, marked “GA Travel Fund,” and sent to 607 Easton Rd., Bldg. E, Willow Grove, PA 19090-2539, after January 1, 2024, but before the 2024 General Assembly which is scheduled to be held June 19-25, 2024.

(3) **WORLDWIDE OUTREACH:** The General Assembly approved the following Worldwide Outreach program for 2024 to support the combined ministries of the Committees on Foreign Missions, Home Missions, and Christian Education.
