The following is a summary of the requests for funds by the 78th General Assembly (2011) **for 2012** and directions as to where to send those funds. *Please note that all of the addresses have changed in important ways from what you have used prior to last year. In particular, "Box P" should no longer be used in any communications and the four digit extension on the zip code has changed.*

(1) **GENERAL ASSEMBLY OPERATION FUND:** The Assembly requested the churches to contribute **\$16.00 for each communicant member** to the 2012 General Assembly Operation Fund.

**Contributions to the General Assembly Operation Fund** should be made payable to *The Orthodox Presbyterian Church*, marked "GA Operation Fund" and sent to 607 N. Easton Rd., Bldg. E, Willow Grove, PA 19090-2539, after January 1, 2012.

(2) **TRAVEL FUND:** The General Assembly requested the churches to contribute **\$12.00 per communicant member** to the 2012 General Assembly Travel Fund. This is the fund that pays for the travel of commissioners to the 2012 General Assembly.

**Contributions for Travel Fund** should be made payable to *The Orthodox Presbyterian Church*, marked "GA Travel Fund" and sent to 607 N. Easton Rd., Bldg. E, Willow Grove, PA 19090-2539, after January 1, 2012 but before the 2012 General Assembly.

(3) **WORLDWIDE OUTREACH:** The General Assembly approved the following Worldwide Outreach program for 2012.
